

1. The Sponsor of the Raffle is Gamergrounds.ph
2. **Eligibility:** Load 4 Gold: Top-up Panalo! (the "Raffle") is only open to those who sign up at **(WEBSITE HERE)**. The Raffle is open only in the Philippines, and is void where prohibited by law. Employees, independent contractors, interns, officers, directors, and agents of Gamergrounds.ph (the "Sponsor") their respective affiliates, subsidiaries, advertising and promotion agencies, suppliers and their immediate family members and/or those living in the same household of each are not eligible to participate in the Raffle.
